At 12:30pm, Regent Kizer called the regular meeting to order and lead the Opening Prayer of 3 Hail Mary's for World Peace. This was followed by the Pledge to the Flag. Minutes of the last meeting, October 22, 2023, were read and approved with one correction. Local correspondence consisted of 2 thank you notes and 1 acknowledgment. 
St. Joseph Stained Glass Saints

#13 Our Lady of Perpetual Help

The icon is unique and renowned due to Mary looking towards the faithful, while pointing at her son, Jesus Christ who is frightened by the instruments of crucifixion and is depicted with a fallen sandal. The veneration of Our Lady under this title is related to a miraculous picture of our Blessed Lady, in the Byzantine style, which was brought to Rome toward the end of the 15th Century and set up for veneration in the Church of St. Matthew the apostle. Before its disappearance in 1812, so many favors and graces were granted that it became natural to speak of "Our Lady of Perpetual Help". The picture was recovered during the time of Pope Pius IX. His Holiness warmly urged that the devotion be revived and he entrusted the picture to the Redemptorist Fathers, where it is today.
